Recommendation

That Council approve that Casper Fire-EMS apply for federal grant funding from the Assistance to Firefighters Grant (AFG) for FY25, allowing for up to \$1 Million in awards per application.

Summary

In exploring potential sources of funding needs for the City of Casper Fire-EMS Department, the AFG grant has been identified as a possible source. Due to identified budgetary constraints, the Casper Fire-EMS has identified and prepared three separate items for AFG funding opportunities:

- Replacement of Rescue 1 (R1); This apparatus is our only designated heavy rescue unit within the city or county that has technical rescue capabilities for all disciplines. R1 is currently 14 years old and needs replacement.
- Training; Funding for costs to train 12 members to the EMT-Intermediate level within our department for adequate ALS services to our community. Casper Fire-EMS has not trained personnel to this level since 2014.
- Training; Funding for a nationally recognized "Blue Card" system to standardize our incident command and control within our organization.

Financial Considerations

The AFG grant has a City of Casper match requirement of 10%, resulting the following match funds: R1: \$1,250,000 (Match funds \$250,000); EMTI Training: \$135,000 (Match funds \$13,500); Incident Command Training: \$123,000 (Match Funds \$12,300). R1 funds options are One Cent or the General Fund. Training funds will utilize the Fire Operations training budget.
