- Specific areas addressed in the training included:
 - Proposing an Amendment to a Motion as well as proposing an Amendment to the Amendment. Please refer to the handout attached titled: "Parliamentary Procedure in Action"
 - It was noted that proposed amendments can be made informally by asking the member making the original motion to consider amendment. This is called a "friendly" amendment. A "friendly" amendment does require a formal vote.
 - o If a member makes a Motion and there is no 2nd, the Motion will die.
 - O When a member wants to end debate on a topic, the member may Move to Close Debate, also known as Call the Question, and this requires a 2nd & 2/3 majority vote as noted in the handout "Parliamentary Procedure in Action."
 - o If Robert's Rules of Order are not being followed, a member may call a Point of Order & state the error that occurred. This does not require a 2nd or vote. A member may appeal to the Chair if the error is not corrected, and this would then require a 2nd and majority vote.
 - o If a decision is voted on and approved by the Council, a member on the "winning side" of the vote may Move to Reconsider the vote at the same meeting.
 - Motions can be made to refer topics to sub-committees for further investigation or to gather more information. This will take a member to Move the topic to a specific sub-committee, a 2nd and then a majority vote.

- O A member may Move to Suspend the Rules to make some discussion more informal. This will require a 2nd, and then a 2/3 majority vote.
- O When a meeting has concluded, the Chair can simply adjourn the meeting, or the Council can have a member Move to Adjourn the meeting which then requires a 2nd, and a majority vote.

The meeting adjourned at 4 PM.

The next meeting will be held on Thursday, September 26, 2019 at 3 PM at City Hall.

- 1. Introductions/Roster Sign-in
- Renate Pullen, Council Secretary, lead the meeting until action items in #5, Election of Chairperson and Vice-Chairperson, took place, and thereafter, the new Council Chairperson lead the meeting.
- 3. <u>Minutes from September 26, 2019 Meeting</u> A motion was made by Art Pauly and seconded by John Wall to approve the minutes, and the voting members voted to accept the minutes from the previous meeting.
- 4. Review of Robert's Rules of Order Zulima Lopez reviewed the process of introducing business that is not currently on the agenda. A person wanting to speak to new business not listed on the agenda would address the Chairperson requesting to speak on the desired topic. The person would need to make a motion, "I move to talk about . . . (the desired topic)" and then get a second and the Council would vote on this. Just a reminder that only one person speaks at a time.
- 5. <u>Election of Disability Council Chairperson & Vice-Chairperson</u>
 - a. Council Chairperson Austin Berlin volunteered to take this position. Austin made a motion to elect her as Chairperson, and Art Pauly seconded the motion. The Council voted and approved Austin Berlin as the new Council Chairperson.
 - b. Council Vice-Chairperson Nikki Green volunteered to take this position. It was moved by Nikki to be Vice-Chairperson and seconded by Renate Pullen. The Council voted and approved Nikki Green as the new Council Vice-Chairperson.
- 6. <u>Old Business</u>: Austin Berlin, Council Chairperson, lead the meeting with discussion from each established Committee Chairperson:
 - *QOL Committee* Mary Price, Chairperson
 - Public transportation expansion and operating times:

- Mary Price updated the Council on the QOL's Committee meeting stating the group had met with John Jones, Executive Director of CATC, and additional funding is needed for more buses. Discussed doing a survey to determine how many people will need to go to the VA via CATC discussed putting the surveys on the buses and on the Facebook page "Friends of CATC." Encouraging people to call for their appointments a week ahead of time to avoid CATC being overloaded. They are working on gathering data on how many rides are being rejected so they can pursue further funding. Discussed bus shelters, and there are extra benches stored and they can be put at locations as requested and as needed. Would like to pursue more bus shelters, but this would require more funding.
- The Committee also discussed putting together helpful tips by putting them on Friends of CATC Facebook page.
- The need for funding discussed John Jones is going to attempt to get federal & state funding for increased transportation across the state.
- Mary to do a fundraiser through Friends of CATC Tie-dyeing event to go toward subsidized tickets for CATC.
- Zulima Lopez clarified a comment on the mechanic situation City of Casper lost 2 technicians that work on the buses, and the City is in process of filling the positions. They don't anticipate this will affect service. Currently there are 8 technicians & a manager in place.
- Public Relations (PR) Committee John Wall, Chairperson
 - The Committee had a meeting at Wyoming Independent Living.
 - (Previously established goals of PR Committee) Focus on increasing public awareness of the disability population and disability advocacy through public events, projects and equal representation on community boards and committees
 - Explore ways of communicating to the public about this Council including alternatives to computers, as not everyone has access to or uses computers, email, social media, etc. –
 - Discussed starting a Facebook page for the Council that is accessible to all individuals with disabilities. Discussed doing a tri-fold brochure to educate the public on the Council as well as the services available in the county. Mary Price moved to have a page dedicated to the Disability Council on the City of Casper's website, and it was seconded by John Wall and the Council approved.
 - Mary Price moved to have a Facebook page established and have John Wall be the page Administrator, and Art Pauly seconded the motion and it was approved by Council. The Administrator role would go to the next PR Committee Chair once John's term is over.

- Zulima Lopez let the Council know that an email address established for the Council was approved. Renate made a motion to establish the Council's email address as: disablitycouncil@casperwy.gov, and it was seconded by Mary Price and the Council approved the email address. The email would go to Zulima Lopez and then she would forward out to the Council. Renate Pullen moved to establish the email address, Mary Price seconded, and it was approved by Council.
- John Wall discussed more collaboration with other entities to participate in events and fundraisers such as David Street Station.
- Austin Berlin discussed making a flyer every quarter to discuss what events are happening and what is going on and get it out to the public.
- Mary Price discussed notifying the Casper Star Tribune each time the flyer is published quarterly. The Committee can work on this.
- (Previously established goals for PR Committee) Focus on providing or coordinating education to businesses and the community regarding ADA supports and accommodations for the disabled population including encouragement for the adoption of universal design.
- Events Committee Nikki Green, Chairperson
 - o Nikki brought a tentative proposal. The committee met to discuss events.
 - The proposal includes establishing Casper Disability Day in March, 2020 for Disability Awareness Month, and create an all-day summit that allows for vendors to attend and provide education. The event would have public speakers, experts in the field and motivational speakers available. Fairgrounds is booked the entire month of March, Nikki left a message for the Events Center, Ramkota Hotel and Clarion Hotel for potential locations & costs. Vendors to pay a fee for booth rental to cover costs.
 - Mayor Powell suggested Food for Thought as a possibility to save costs, but smaller venue.

Zulima Lopez has reached out to the City Attorney and Financial Services Director to discuss the issue of tax-deductible donations and this is pending. Where do we put the money if we get donations? They are working with the Cheyenne Disabilities Council to see how that works. Michelle Onstott stated that she is working with one of the individuals who works with the Cheyenne Disability Council, and she can invite her to one of our meetings to discuss how they operate.

They have specialized technology for the blind to use in public restrooms, and their mission is to equip public restrooms with way-finding devices with specialized tape on the floor as well specialized canes that communicate with the tape on the floor.
- 8. It was decided that the next meeting of the Council would be moved to the 3rd Thursday, November 21, 2019 at 3 PM due to the Thanksgiving holiday on the 4th Thursday.

The meeting adjourned at 4:13 PM.

The Board meeting was called to order at 11:35 a.m.

1. In Announcements, Mr. Martin stated that Mr. Steve Cathey will be officially appointed to the Board by the Casper City Council tonight. The Board welcomed Board Member

Cathey back to the Board.

- 2. Chairman King asked for a motion to approve the minutes from the July 16, 2019 meeting. A motion was made by Board Member Powell and seconded by Secretary Waters to approve the minutes from the July 16, 2019 meeting. Motion put and carried with Board Member Cathey abstaining from the vote.
- 3. Mr. Martin informed the Board that no additional vouchers were added to the voucher listing. Mr. Martin recommended approval of the vouchers and offered to answer any questions the Board may have on the voucher listing.

Chairman King asked for a motion to approve the August 2019 vouchers. A motion was made by Secretary Waters and seconded by Board Member Freel to approve the August 2019 voucher list to include voucher numbers 8047 through 8055 in the amount of \$681,265.04. Motion put and carried.

4. Mr. Martin asked the Board to reference the Gallons Produced table in the agenda packet. Mr. Martin stated that production for July 2019 was 692 MG, which is 39 MG over the five year average of 653 MG.

Mr. Martin stated that Water Revenue for July was \$1,336,184.

Mr. Martin stated that the City Finance Department is still working on closing out the last fiscal year and getting ready for the annual audit. Mr. Martin stated that he hoped things will be back on track next month.

Chairman King asked for a motion to approve the July 2019 Financial Report as presented. A motion was made by Board Member Powell and seconded by Secretary Waters to approve the July 2019 Financial Report as presented. Motion put and carried.

Treasurer Bertoglio arrived at 11:38 a.m.

5. Chairman King turned the time over to Mr. Schroeder for the Operations Update.

Mr. Schroeder stated that staff has been fighting leaks on the ozone groundwater contactor all summer. Mr. Schroeder stated that this past week staff was able to install a new valve in the ozone injection room which helped stop some of the water flow. Mr. Schroeder stated that a plug was inserted in the drain that was leaking on the other contactor which helped stop the leak. Mr. Schroeder stated that now the groundwater production is where it should be, over 10 MGD.

Mr. Schroeder stated that the leaking contactor is slowly being drained. Mr. Schroeder stated that when the contactor is drained and dry, staff will go inside to make repairs, then put it back in service. Mr. Schroeder stated that the drain valve will need to be replaced once the river level goes down.

Mr. Schroeder stated that August production is starting to decline, which is normal.

Mr. Schroeder stated that there have been some issues getting chemicals due to lack of drivers and trucks for the chemical companies. Mr. Schroeder stated that this happens quite often during the summer months. Mr. Schroeder stated that the sodium hypochlorite was starting to run low, but a truck came in today, and three more trucks are scheduled for this week.

Mr. Schroeder stated that one of the backwash/sludge lagoons failed. Mr. Schroeder stated that staff was able to take it completely out of service and are using the other sludge lagoon. Mr. Schroeder stated that it is on the schedule for Water Distribution staff to clean it out and get it back in service. Mr. Schroeder stated that the gate had rotted out and wasn't able to do its job. Mr. Schroeder stated that water was running out the bottom of the gate and created a river through the mud, which is 2-3 feet deep.

Mr. Schroeder stated that next month Water Distribution staff will be flushing the RWS transmission system. Mr. Schroeder stated that a meeting will be held with the operators from the wholesale entities prior to the start of the flushing so they can coordinate flushing of their systems at the same time.

The time was turned over to Mr. Conner to give the Transmission System Update.

Mr. Conner stated that staff has been updating the RWS waterlines, size and type of material, in GIS. Mr. Conner stated that he got some plans from Poison Spider the other day so their waterlines will be updated as well.

Mr. Conner stated that the small motor was installed at the Wardwell booster and has been aligned. Mr. Conner stated that he is still waiting on the four-inch check valve for the same pump.

Mr. Connor stated that the EPA compliance sampling has been completed for the month.

Mr. Conner stated that towards the end of last week, sampling showed that nitrification has started in the Sandy Lake and Pioneer water tanks. Mr. Conner stated that flushing of the RWS system will start in mid-September and hopes it will be completed in three to four weeks.

Mr. Conner stated that anode testing was completed on the Crosstown Pipeline and everything is good.

Mr. Conner stated that staff has been trimming grass and cutting down weeds at the RWS booster stations and water tanks.

Mr. Conner stated that he has been busy putting together the required documents for the upcoming EPA Sanitary Survey.

Chairman King asked how the new Airport Elevated Water Tank has been working. Mr. Conner stated that everything is good with the Airport Elevated Water Tank; it is working

how it is supposed to.

- 6. There was no Public Comment.
- 7. There was no Old Business.
 - a. There was no Other Old Business.
- 8. In New Business:
 - a. Mr. Martin stated that there is bad news on the 2.6 MG Water Tank Recoating Project.

Mr. Martin stated that the Board approved the contract for the project in May, and the contractor started sand blasting in July. Mr. Martin stated that the contractor had concerns when they got to the ceiling, and stopped working until an inspection could be done.

Mr. Martin stated that Lower and Company was hired to do the inspection and they found there is severe corrosion of the members supporting the roof. Mr. Martin stated that the rafters and interior beams show severe corrosion and as much as 50% of the cross section of the flanges of these members have to be removed. Mr. Martin stated that it also appears that settlement of the tank floor has caused significant rotation of many rafters and interior beams.

Mr. Martin stated that the tank walls are in serviceable condition, and the tank floor is also in serviceable condition with the exception of some isolated areas near the effluent that require repair.

Mr. Martin stated that the inspector recommends that if the tank is to remain in service for more than just a few years, the roof should be completely reconstructed.

Mr. Martin stated that the contractor, Riley Industrial Services, left the work site and a change order is being negotiated for them to come back after the roof has been replaced.

Mr. Martin stated that HDR has been contacted to submit a proposal for design, permitting, and construction administration for the roof replacement. Mr. Martin stated that Mr. Colling is reaching out to the original tank contractor to see if they are interested in replacing the roof.

Treasurer Bertoglio asked if the tank will be put back in service while the roof design is being done. Mr. Martin stated that it will not be put back in service, it has been out of service all summer. Treasurer Bertogio asked if it could be put back in service if there was an emergency. Mr. Schroeder stated that the tank is not able to be used at this time as it is structurally unsafe.

Treasurer Bertoglio asked if it is cost effective to just replace the roof or if it would be better to replace the tank. Mr. Beamer stated that a new tank would cost approximately 2 - 3 M, and a new roof would cost approximately 500,000.

Board Member Cathey asked if the tank walls are in good shape. Mr. Beamer stated that once the walls of the tank are recoated, they should be good.

Mr. Martin stated that the new roof was not budgeted, so staff has been reviewing the list of FY20 projects to see which ones can be cut from the budget and rebudgeted next year. Mr. Martin stated that it is possible that a budget amendment will need to be considered.

Treasurer Bertoglio asked how long it would take to get the roof completed. Mr. Martin stated that with design, permitting, putting it out to bid, and construction, it would take about a year before the contractor would be able to finish the recoating project.

Mr. Martin informed the Board that he hoped to have a contract for design, permitting, and construction administration for the Board's consideration at the next meeting.

- b. There was no Other New Business.
- In the Chairman's Report, Chairman King asked Mr. Chapin if he has heard anything further from the Town of Mills regarding moving the waterline. Mr. Chapin stated that he has not heard from them.

Chairman King stated that the next regular meeting will be held on September 17, 2019.

A motion was made by Secretary Waters and seconded by Board Member Freel to adjourn the meeting at 11:55 a.m. Motion put and carried.

The Board meeting was called to order at 11:30 a.m.

1. There were no Announcements.

- 2. Chairman King asked for a motion to approve the minutes from the August 20, 2019 meeting. A motion was made by Treasurer Bertoglio and seconded by Secretary Waters to approve the minutes from the August 20, 2019 meeting. Motion put and carried.
- 3. Mr. Martin informed the Board that two additional vouchers were added to the voucher listing: voucher 8065 for Wyoming.com for the annual RWS Website Domain Hosting in the amount of \$60; and voucher 8066 for West Plains Engineering, Inc. for the WTP Raw Water Building MCC Replacement Project in the amount of \$8,100. Mr. Martin recommended approval of the vouchers and offered to answer any questions the Board may have on the voucher listing.

Chairman King asked for a motion to approve the September 2019 vouchers. A motion was made by Secretary Waters and seconded by Vice-Chairman Keffer to approve the September 2019 voucher list to include voucher numbers 8056 through 8066 in the amount of \$561,066.18. Motion put and carried.

4. Mr. Martin asked the Board to reference the Gallons Produced table in the agenda packet. Mr. Martin stated that production for August 2019 was 622 MG, which is 14 MG over the five year average of 608 MG. Mr. Martin stated that year to date production is 1.31 BG compared to the five year average of 1.26 BG. Mr. Martin stated that FY20 is starting out to be a good year for water sales.

Mr. Martin stated that Water Revenue for August was \$1,200,491.

Mr. Martin stated that the City Finance Department is still working on closing out the last fiscal year and getting ready for the annual audit. Mr. Martin stated that there have been some technical difficulties with the new financial software this month so the financial report is not ready. Mr. Martin stated that he hoped things will be back on track next month.

Chairman King asked for a motion to approve the August 2019 Financial Report as presented. A motion was made by Vice-Chairman Keffer and seconded by Secretary Waters to approve the August 2019 Financial Report as presented. Motion put and carried.

5. Chairman King turned the time over to Mr. Schroeder for the Operations Update.

Mr. Schroeder stated that the Instrumentation and Controls Technician resigned last week. Mr. Schroeder stated that this is a very important position at the WTP and he is hoping to have the position filled by the end of November.

Mr. Schroeder stated that water demand has been dropping off over the past week or so and is currently at 14 MGD, which is down from 29 MGD.

Mr. Schroeder stated that staff is working on winterizing the wells. Mr. Schroeder stated that all 29 wells must have the thermostats and heaters checked and repaired before winter hits.

Mr. Schroeder stated that staff is preparing for the EPA Sanitary Survey. Mr. Schroeder stated that he has not yet been notified when it will take place, but everything should be ready when EPA arrives.

Mr. Schroeder stated that things are slowing down and it has been quiet.

The time was turned over to Mr. Conner to give the Transmission System Update.

Mr. Conner stated that chloramine residuals are starting to drop and nitrification is starting to be seen out in the system.

Mr. Conner stated that the system flushing that was discussed last month will be starting today. Mr. Conner stated that staff will be flushing RWS waterlines heading out to Pioneer, Poison Spider, the Airport, and up north. Mr. Conner stated that staff has been in contact with the other systems operators so they can flush their systems at the same time. Mr. Conner stated that staff will also be flushing the City system.

Mr. Conner stated that the Wardwell Tank was cleaned last week and the roof was replaced. Mr. Conner stated that the contractor should be back on site this week to do the cathodic protection and skirting. Mr. Conner showed a video of the roof being replaced. He stated that it didn't take very long to remove the roof and put the new one on as the new roof was built off site. Chairman King asked if the new roof looked more stable than the old roof. Mr. Martin stated that he noticed that there was some extra bracing on the roof sections.

Mr. Connor stated that staff is still waiting on a check valve for one pump at the Wardwell Booster.

Mr. Conner stated that mowing at the booster and tank sites was done this past week.

- 7. There was no Old Business.
 - a. There was no Other Old Business.
- 8. In New Business:
 - a. Mr. Martin stated that occasionally the wholesale water entities come forward to request enlargement of their district. Mr. Martin stated that Pioneer Water and Sewer District has submitted the following three petitions for enlargement:
 - Kelly and Nikki Faylor 11749 W Poison Spider Road 72.45 Acres Contiguous to Pioneer. The Board discussed this parcel previously regarding an easement and one tap.
 - Philip and Lori Johnson 7600 Poison Spider Road 13.8 Acres Contiguous to Pioneer, but not requesting a tap at this time.

• Donaldo Hermosillo and Brenda Guzman – 7808 Poison Spider Road – 176.31 Acres – Contiguous to Pioneer, requesting one ³/₄-inch tap.

Mr. Martin stated that all three petitions have been approved by the Pioneer Water and Sewer District Board and have been sent to the Natrona County Commissioners for approval. Mr. Martin recommended approval of the enlargement request for Pioneer Water and Sewer District.

Treasurer Bertoglio asked if any of the people requesting annexation to Pioneer inquired with Lakeview or Mile-Hi. Mr. Martin stated that one of the property owners did inquire with Mile-Hi, but Mile-Hi was not interested in enlarging their district.

A motion was made by Treasurer Bertoglio and seconded by Vice-Chairman Keffer to approve the three petitions for enlargement for Pioneer Water and Sewer District as discussed. Motion put and carried.

b. Mr. Martin asked the Board to reference the agreement with Don's Mobile Carpet, Inc. for the replacement of 3,240 square feet of carpeting and 600 linear feet of 4-inch cove base in the WTP Administration areas. Mr. Martin stated that the existing flooring is 20+ years old, the high traffic areas are extremely worn, and the staining cannot be removed.

Mr. Martin stated that the existing flooring will be replaced using carpet tiles as opposed to the traditional carpet rolls. Mr. Martin stated that additionally, 900 square feet of extra tiles will be purchased so high traffic areas can be replaced as needed.

Chairman King asked if the carpet was going to be replaced in the conference room as well. Mr. Martin stated that the carpet in both the small and large conference rooms, the offices, lobby, hallways, and entry ways will be replaced.

At a very high level, here is how it works. Instead of having to build out our physical network over significant distances to serve customers in less densely



John "Lucky" Luckadoo Remembers His WWII B-17 Missions

It was an honor to recently host a conversation with Greatest Generation's John "Lucky" Luckadoo, B-17 pilot and WWII veteran of the 100th Bomb Group. CITY OF CASPER CONTRACTOR CLASSIFICATIONS

CLASS I – A Class I license authorizes the contractor to construct, repair, or alter any structure (residential or commercial). The criteria for a Class I General Contractor requires at least eight years of construction experience in the category of a general contractor license being applied for.

CLASS II – A Class II license authorizes the contractor to construct, repair, or alter all residential and commercial structures up to twelve thousand square feet. The criteria for a Class General II Contractor requires at least six years of construction experience in the category of a general contractor license being applied for.

CLASS III – A Class III license authorizes the contractor to repair, remodel, or alter single-family residences ONLY up to 25% of the assessed value. The criteria for a Class III General Contractor requires at least four years of construction experience in the category of a general contractor license being applied for.

ROOFING CONTRACTOR – A Roofing Contractor's license authorizes the contractor to install, repair, or construct roofs and associated roofing materials. The criteria for a Roofing Contractor requires at least one year of roofing experience in the construction trade.

DEMOLITION CONTRACTOR – A Demolition Contractor's license authorizes the contractor to demolish and remove any structure or building. Demolition contractors must abide by the rules and regulations set forth by the Department of Environmental Quality (DEQ).

MOBILE HOME CONTRACTOR —A Mobile Home Contractor's license authorizes the contractor to set a mobile home, which includes blocking, leveling and installation of tie downs. A mobile home contractor license may be issued to an individual with a mobile home installer license. The criteria for a mobile home installer requires at least one year of experience.

ELECTRICAL CONTRACTOR – An Electrical Contractor's license authorizes the contractor to perform electrical work on any structure or building. The City of Casper may issue an electrical contractor's license with a valid State of Wyoming electrical contractor and master's license, which are issued by the State Fire Marshal's Office. Criteria of experience in the electrical trade is set forth by the State of Wyoming Fire Marshal's Office.

LOW VOLTAGE CONTRACTOR – A Low Voltage Contractor's license authorizes the contractor to perform low voltage electrical work on any structure or building. The City of Casper may issue an electrical low voltage contractor's license with a valid State of Wyoming low voltage contractor and technician license, which are issued by the State Fire Marshal's Office. Criteria of experience in the electrical trade is set forth by the State of Wyoming Fire Marshal's Office.

MECHANICAL CONTRACTOR – A Mechanical Contractor's license authorizes the contractor to perform HVAC work on any structure or building. A mechanical contractor license may be issued to an individual with a master mechanical license. The criteria for a master mechanical license is a total of nine years of experience in the HVAC trade, five of those years as a journeyman.

PLUMBING CONTRACTOR – A Plumbing Contractor's license authorizes the contractor to perform plumbing work on any structure or building. A plumbing contractor license may be issued to an individual with a master plumbing license. The criteria for a master plumbing license is a total of nine years of experience in the plumbing trade, five of those years as a journeyman.

UTILITY CONTRACTOR – A Utility Contractor's license authorizes the contractor to perform unground utility work, such as water and sewer services. A utility contractor license may be issued to an individual with a utility installer's license. The criteria for a utility installer is one year of experience in the utility contracting trade or one year of experience with a licensed plumber.

All licensed contractors are required to pull permits for work being performed within City limits, as per Section 12.12.030A of the City of Casper Municipal Code, and are required to have a valid certificate of insurance on file with the City of Casper Community Development Building Division, as per Section 15.12.150 of the City of Casper Municipal Code.

The City of Casper Contractors' Licensing and Appeals Board plays an integral part in reviewing approving most licenses. A list of licensed and qualified contractors is posted on the City's website at https://www.casperwy.gov/residents/property and housing/building and inspections. The list is updated quarterly.

Dear City Council Members,

We are writing in response to the Council's consideration of parking meters in the downtown district. My partner, Hugh Jenkins, and I have had Wind City Books here on Center Street for the last 12 years. With the improvements you have brought to downtown through David Street Station, lighting, and street repairs, etc. we have seen an uptick in foot traffic that has translated into an increase in business in our store and it is deeply appreciated.

For 12 years we have listened to our customers' concerns regarding parking and have done our best to try to help. We currently rent 2 spaces at the 1st and Center lot and require that part-time employees park outside the downtown district. We also purchase parking vouchers and validate parking for our customers. When there was an employee consistently monitoring the parking on the streets parking turnover was consistent and there were fewer complaints. At this time we have a problem with other business' employees and employees of the Wyoming Department of Employment parking on the street during business hours. We do need a solution, however, parking meters are not it. The impact on downtown commerce will be severe.

We face fierce competition from internet businesses like Amazon as it is. This community has already seen the impact of online shopping in the loss of two of the largest retailers in our mall, Sears and Macy's. Putting in parking meters will drive our customers to the internet to purchase their books from Amazon where they will not only get them at wholesale prices; they won't have to pay for parking.

We currently employ five people in addition to ourselves and remit \$1500-\$2000 per month in sales taxes with double that in the Christmas season. If our sales should decrease, we will have to let employees go and certainly, our sales tax remittance will be much less. Our business is not the only one that will face this problem. The mall has approached us multiple times asking us to relocate with them. We chose to open our business downtown because we feel that a vital downtown is essential for a healthy community but the installation of parking meters will make that a much more viable option. There will be plenty of parking available because the businesses will no longer be here. This will not be beneficial for either the city of Casper or its citizens.

We respectfully request that you please consider the impact to downtown businesses, bring back the parking monitor, and dispense with the idea of meters.

An Open Letter to the Members of the Casper City Council.

Re: Failure of the Sale of the Plains Furniture Property on 10.16.19

The undersigned members of the downtown business community are disappointed and frustrated at the outcome of the vote to not finalize the sale of the Plains Furniture Building at the City Council Meeting held on October 15, 2019. As a group we have been excited about the prospect of this property finally receiving the private attention and investment needed to truly transform this blighted and vacant location into a vibrant and thriving enhancement of the downtown revitalization effort. A recently completed City funded study (The Generation Study) highlighted the need for market rate housing in our City's downtown core. Meeting this important need is exactly what the "Nolan" project will do, further building on and solidifying the revitalization of the heart of Casper's historic downtown.

We have heard various comments about the City buying the property for \$3,000,000 and selling it to this project for only \$500,000. These comments, while very public, are simply not true. The City has previously sold 3 large parcels of the original property and is currently retaining another. We understand that on its face, this still may seem as if the City is losing money on this sale, however the original sales price is only the cost of admission for this full development. This development group is fully prepared to spend upwards of \$8,000,000 on this revitalization project, making it the second largest single investment into downtown Casper in recent history, only eclipsed by the construction of the new state office building. We do not think there is another entity, public or private, that is willing to invest this level of capital into this property now, or in the future.

We have seen the estimate of new annual taxable sales provided by the development group, and feel that they are accurate, albeit conservative. Once completed, we believe the residential occupancy (estimated 43 permanent residents) and commercial lease space (estimated 50 employees) will allow the Nolan development to generate over \$1,000,000 in new downtown sales and over \$90,000 in sales and property taxes annually. This is a benefit that not only fills the gap in the initial property sales price, but is one that continues and is spread throughout the greater downtown Casper area.

A key point that has not been adequately addressed is that this proposal includes demolition of the building affectionately known as the "Livery Stable". This building is aesthetically detrimental to downtown and is currently condemned by the City of Casper. It poses a significant risk to the public visiting downtown on a weekly basis, a risk that this development group is willing to assume and remove.

We feel it is important to note there is a critical difference with this project that has not been properly discussed. From day one, this project will be fully funded privately by this development group. We have seen other projects with great intentions stall, change course, lose momentum, and also stop simply because they were not properly financed. We look to this project as not only an immediate impact to downtown Casper and its many businesses, but also as inspiration for other parties interested in making significant investments in Casper.

Additionally, it should be noted that this development group has already secured a long-term lease agreement with a high level technology business, that is homegrown here in Casper, and hopes to remain based in Casper, housed in the Nolan. This company has the very real potential to employ a

significant workforce, making high level salaries that contribute to the overall economic diversification we continue to hear about, but rarely see actually implemented in Casper. As the larger picture of Wyoming's fossil fuel based economy continues to be questioned, this level of diversification based in Casper, is what our future success depends on.

Good Morning,

My name is William Scott, and I am writing this email in support of the proposed changes to Municipal Code 12.32 Trees and Shrubs.

I realize this is only one man's opinion, but as it is potentially the most important thing to happen to Casper's trees in the history of our community I feel that I should put in my thoughts for what they are worth.

I have spent most of the last 25 years working with trees and educating the public, as well as other arborists about the benefits they provide. I may have met, or spoken with some of you in that capacity. One of my first jobs was working for your City Weed and Pest Dept. I have been an arborist for the Natrona County School District (1998-2007), The City Forester for the City of Casper (2007-2010), owner of my own tree service (2010-2016), and most recently as the Plant Health Care Division supervisor at All Trees here in Casper. I have served on the International Society of Arboriculture -Rocky Mountain Chapter as the Wyoming State Director, and as a board member and president of the Wyoming Groundskeepers and Growers Association, and as president of Forever Trees Urban Forestry Advocacy Group. I am an ISA Certified Municipal Specialist, and am the only ISA Board Certified Master Arborist in the state of Wyoming. I am also responsible for training, at least in part, most of the arborists across Wyoming, and across the region over the past 20 years or so, including the arborists on your City Parks staff. If credentials matter to you, that is who I am. For myself they don't mean much, they are a byproduct of a career spent trying to learn about and to contribute something worthwhile to my community now and for the future, but I guess I might know a little bit about trees.

Possibly the greatest benefit trees provide us is the ability to touch the future in a very real, very tangible way. They allow us to leave a living legacy to benefit our children, our children's children, and generations beyond that. They allow us to to contribute something positive to the future in a way that not many other things can. That is why I work with trees - to give something back that is greater than myself. I know that if I use my knowledge and skills to the best of my ability, I am helping to protect that legacy and provide something of value to not only my children, but also to people I will never meet. By teaching other arborists, and promoting trees in our communities I can help other people do the same. That is why I am writing this email.

I could write pages detailing the benefits that trees provide, how they are the one part of our infrastructure that has the potential to increase in value over time, but it is the legacy of trees that is most important, and it is that legacy that this ordinance has the greatest potential impact on. I believe the changes that have been proposed to this ordinance

are necessary. To put it in the right perspective, they are necessary because trees remember everything that has ever happened to them every day of their lives. Every injury, every sickness, how much sun, how much rain, what the soil was like, its all there recorded forever. Trees are honest - they never lie. They will tell you their story if you ask. That includes how we treat them.

The existing ordinance, as it stands now, does not provide a very good setting for that story, and does not provide that future legacy for our community's trees, and does less than nothing to protect the citizens of Casper. The proof of that has already been tragically demonstrated. Municipal codes and ordinances cannot be static. They have to be dynamic and adaptable to be effective. We need to realize that the ordinance that we have in place now has failed. It needs to change. We cannot continue to turn a blind eye to that fact or its consequences. We have to do better.

To me supporting the changes to the ordinance give the Casper City Council a rare opportunity to do what any good council is supposed to do, something of greater importance to our community than the typical day to day minutiae you normally deal with. This is the opportunity to set a professional standard of care. To protect and provide for that legacy of trees. it allows you to touch those future generations, and impart on them that we had the wisdom to promote the care of one of our most valuable assets, our citizens, and our community. That is important.

I realize that no law is perfect, and that this one is no different. It may not have the "teeth" that we want it to have right now, but it has more than we currently have. I know there will always be people that choose to ignore the law, but right now there is no law to ignore. These are issues that can be addressed over time and are poor excuses to stop the adoption of the proposed changes. It is setting the standard that is important - taking that first step. If we do not do that we will never make any progress, and this law will continue to stagnate, our trees and community will suffer, and we will be lesser for it. By setting the proposed standards for insurance, consequences for violations, and the ISA Certified Arborist standard we are drawing a line and saying "This is what is acceptable - No less" we have to do that or we will never be able to address any of the other issues.

It is the ISA Certified Arborist requirement that is possibly the most important change. I have heard some complain that they shouldn't need to be certified. Being an ISA Certified Arborist means more than just knowing something about trees. It also means you have an ethical responsibility to the trees you are caring for and the other arborists, customers, and people concerned with that care. I have attached the ISA code of ethics that every ISA Certified Arborist and BCMA agrees to when they become certified. These are the people we are promoting with the ordinance change and I encourage you read those ethics agreements. I think you will agree that the folks who sign to them are who we want caring for our trees, and that is the standard we want to set. I would have some serious reservations about hiring anyone to work on my trees that doesn't see the value in certification, the knowledge required, or understand the need for ethical professionals in our industry.

Thank you for taking the time to read this, and I hope that you take it into consideration during the next vote.

 - 3. Provide accurate, complete, and truthful representations concerning all certification and renewal information.
 - 4. Maintain the security of ISA examination information and materials, including the prevention of unauthorized disclosures of test information.
 - 5. Cooperate with ISA concerning ethics matters and the collection of information related to an ethics matter.
 - 6. Report to ISA, in a timely manner, their personal conduct that may violate any provision of the <u>ISA Code of Ethics</u> or the <u>Ethics Case</u> Procedures.
 - 7. Refrain from behavior or conduct that is clearly in violation of professional, ethical, or legal standards related to occupational services and/or activities.

- II. Responsibilities to clients, employers, employees, and the public.
 - A. Responsibilities concerning the performance of professional services. Credential holders and candidates must:
 - 1. Deliver safe and competent services with objective and independent professional judgment in decision-making.
 - 2. Recognize the limitations of their professional ability and provide services only when qualified. The credential holder/candidate is responsible for determining the limits of his/her own professional abilities based on qualifications, education, knowledge, skills, practice experience, and other relevant considerations.

 - 5. Properly use professional credentials, and provide truthful and accurate representations concerning education, experience, competency and the performance of services.
 - 6. Provide truthful and accurate representations to the public in advertising, public statements, and other representations, and in the preparation of estimates concerning costs, services and expected results.
 - 7. Recognize and respect the intellectual property rights of others and act in an accurate, complete, and truthful manner, including activities related to professional work and research.
 - B. Responsibilities concerning conflicts of interest and appearances of impropriety. Credential holder and candidates must:
 - 1. Disclose to clients or employers significant circumstances that could be construed as a potential or real conflict of interest or an appearance of impropriety.
 - 2. Avoid conduct that could cause a conflict of interest with a client, employer, employee, or the public.

- 3. Assure that a conflict of interest does not compromise legitimate interests of a client, employer, employee, or the public and does not influence or interfere with professional judgments.
- 4. Refrain from offering or accepting significant payments, gifts or other forms of compensation or benefits in order to secure work or that are intended to influence professional judgment.
- C. Responsibilities concerning public health and safety. Credential holders and candidates must:
 - Follow appropriate health and safety procedures, in the course of performing professional activities, to protect clients, employers, employees, and the public from conditions where injury and/or other harm are reasonably foreseeable.
 - 2. Inform appropriate government representatives or agencies when aware of an activity or circumstance that may cause an unsafe condition or violate legal requirements.


Summary:

One option being considered for a new Public Safety Facility is 'New Construction' on property located in the Platte River Commons - north of 13th Street and west of King Boulevard. With the proximity of this site to the North Platte River, consideration needs to be given to the flood hazard of the area.

The Federal Emergency Management Agency (FEMA) determines flood zones for communities. Flood zones classify the probability an area has of flood risk. There are 15 categories to classify flood zones. Areas subject to inundation by the 1% annual chance flood – or 100-year storm event, are classified as Special Flood Hazard Areas (SFHAs). Other flood areas are generally classified as areas of a 0.2 % annual chance flood – or 500-year storm event.

The Platte River Commons site is located outside of the SFHA, but is located within the 0.2% annual chance flood zone, also referred to as Zone X. This is considered to be a moderate to low risk area. The flood hazard map is attached to this memo.

Summary:

One site being considered for a new Public Safety Facility is at the northeast corner of East 12th Street and South Conwell Street. Adjacent Highland Cemetery and Life Steps Campus, the 10-acre site is centrally located and within 2-miles or less of downtown, Casper College, the Wyoming Medical Center, and various educational facilities and retail stores.

The site is vacant and relatively level, sloping from the southeast to the northwest at a grade of approximately 5 percent. The soils are considered expansive, likely requiring the use of drilled piers for building foundations. On-site soils will also not be suitable for re-use as backfill, but would be suitable for site grading.

At one time, the site was considered as the location for the Veterans Skilled Nursing Facility. During site considerations, concern was raised over possible contamination at the location. In response, the City hired Strata, a local geotechnical firm, to perform a field investigation. They drilled six borings, ranging in depth from 15-ft to 20-ft, for the purpose of screening for hydrocarbons. Hydrocarbons were not detected in any of the borings. Their report is attached.

Greetings Mr. Sveda:

Strata, Inc. (STRATA) conducted a field investigation to obtain samples of on-site soil at the northwest corner of East 12th Street and South Conwell Street to field screen the on-site soil for the presence of hydrocarbons.

We drilled six borings to depths ranging from 15 to 20 feet below the ground surface at the site, see attached Boring Logs B-81 through B-86 for the purpose of field screening for hydrocarbons. Field screening included visual and olfactory observations only. We did not detect the presence of hydrocarbons in the samples taken from the borings shown on the attached Boring Location Diagram. We did not perform laboratory testing or an environmental assessment of the site. Soil and/or contamination may vary beyond or between the exploration locations. Variation may not be apparent until any development activities or additional environmental assessments are performed. This acknowledgement is in lieu of all express or implied warranties.





Good afternoon!

Glenrock is presenting this document for your serious consideration of a question: "Why doesn't Wyoming have a similar document extolling the virtues of Wyoming being the best place in the United States for Carbon Capture?" The attached PowerPoint presentation was presented at the International Pittsburgh Coal Conference (prepared by EERC; Energy & Environmental Research Center) in September of this year. Glenrock Energy believes this to be an excellent template dealing with the multiple and varied effects of Carbon Capture, Utilization and Storage (CCUS) to an economy such as the State of Wyoming. Glenrock's advocacy, based on initial work that we have completed, supports that the economic case for installations in Wyoming is potentially more compelling than that which was presented in the North Dakota case study. The State of Wyoming is facing significant hardships for communities, for revenue deficiency of counties and state coffers and the specter of much higher electricity prices (anticipated future state) that will have to be embraced if coal as the primary fuel source for electrical generation is abandoned; with the likely side effect that the opportunities for significant EOR growth remain stranded. As attention-worthy as the gloomy view is for a future absent of coal-fueled electricity generation future, the EERC presentation is a reasonable analog for the shining view of a successful CCUS landscape in Wyoming. A strategic economic trajectory that provides huge economic benefits that can be seized if Wyoming acts deftly and assertively to advance wide-spread implementation of CCUS.

In summary, Glenrock believes that a Wyoming-focused study using this EERC format (in conjunction with the yet to be commissioned Wyoming coal-fueled power generating station studies pledged to be completed by the U.S. Department of Energy and The National Energy Technology Laboratory (NETL) {as was done for the Comanche Generating Station}) is imperative. Wyoming stands to gain immensely from the ready-to-assess opportunities that exist within the State for implementing proven post-combustion carbon capture technology [a la Petro Nova], which possesses a TRL-9 certification [Department of Energy] - a technology which, under the Petra Nova installation is also expected to demonstrate commerciality. In the alternative, should there not be a groundswell of State support to develop and publish this form of scientific and economic study, the collective task to promote coal as a near carbonneutral energy source, preserve coal-fueled power generating station employment and to provide substantial economic benefit to Wyoming will be much more difficult.

Please take a look at the attached presentation and provide any comments to the appropriate influencers that you are connected with to support a path forward for commissioning a similar study in Wyoming. Glenrock stands ready, willing, and able to assist in this effort.





- Coal conversion tax: tax reduction with CO₂ capture (up to 50%)

- No sales tax on construction of pipeline
- Property tax-exempt for 10 years (equipment)

- No sales tax on CO₂ EOR infrastructure
- 0% extraction tax for 10 years for tertiary incremental recovery
- Production tax still applies



Build Plan for CO₂ Capture Plants




State Revenue and Economic Activity




FULL POTENTIAL FOR CONVENTIONAL EOR

- If additional conventional oil fields were added to the study, up to 1 billion barrels of additional oil recovery would be possible.
- Estimating the additional severance taxes and royalties collected on EOR barrels of oil at \$65/barrel, this could add \$300,000,000/year to annual state revenue.
- Over 30 years, this could result in \$>45 billion in economic impact and 15,000 long-term jobs per year.



CONCLUSIONS

- The lignite industry has a significant economic impact on the state of North Dakota.
- Carbon capture will link the lignite industry to the oil industry, enhancing potential economic output for each sector.
- Working together, we can unlock a new opportunity for the state.





Subject: Latest CREG Report and Your Municipality

Good Morning WAM!

By now you've probably heard about the gloomy outlook projected in the Consensus Revenue Estimating Group's (CREG) October report that was delivered to the Joint Appropriations Interim Committee Tuesday morning in Riverton.

Good news first – revenues are beating previous forecast expectations. End of biennium surplus in the General Fund is expected to exceed \$61 million, while the School Foundation Program Account will finish with an estimated \$55.3 million windfall. This unanticipated bounty is credited mostly to large pipeline construction projects, robust retail sales and online sales and use tax generated by newly enacted legislation. Also positive was a reported \$180.4 million increase (97.7%) in investment income from the Permanent Wyoming Mineral Trust Fund in fiscal year 2019.

While all this good news was noteworthy, many were quick to temper their excitement. The large influx of cash coming in due to pipeline construction will be relatively short-lived, as those projects move towards completion. Also, as anyone who has investments knows, the stock market is cyclical, and a slowing U.S. economy could have devastating effects on Wyoming's investment portfolio.

The bigger issue is of course increased uncertainty and continued decline in the state's coal business. Forecasters expect a 10% to 15% decrease in mineral severance tax revenues from 2020 through 2024 according Wyoming State Economist Dr. Wenlin Liu.

Those concerns, coupled with volatility and relatively low prices for oil and natural gas, has the CREG predicting a \$185.4 million drop in state revenues over the next three years, all while the Department of Education, WYDOT and others are already showing budget shortfalls in the hundreds of millions.

Governor Gordon may have put the realities of the situation in the best focus in his news release about the report.

"Wyoming is accustomed to boom/bust cycles – what economists like to call 'market cycles,'" Gordon said in the release. "But this time, I believe we may be experiencing a more fundamental change that will affect how well we can fund government services going forward." So, what does that mean for you and your municipality?

In the short term, while these numbers are sobering, they're actually slightly better than expected. The legislature will undoubtedly have tough decisions to make over the next several biennium budgets, and the work of diversifying Wyoming's economy becomes more and more crucial with each passing year. There will certainly be challenges and we will need to stay vigilant in our defense of what we have now (e.g. direct distribution) while continuing in our efforts to carve out a justifiably larger piece of the pie.

There may be some positive side effects though. As we continue to advocate for more freedom in generating revenue for ourselves this session with legislation that would solidify municipal budgets by making the fifth penny permanent and adding a seventh penny municipal option, we may find a legislature more open to new alternative revenue streams.

It's going to be critical though that we keep taking ideas to the capitol, and that we speak with one voice. That the cities speak up and speak out in defense of our towns and vice versa when legislation stands to harm one group or another. WAM can be as influential as any advocacy organization in the state, but that influence, and power is only going to be as strong as the ties that bind us. So, keep up the great work you do making your communities the ever-improving places that they are and we'll keep fighting every day on your behalf and by your side to keep Wyoming's cities and towns thriving.

Kemmerer Wins Federal Grant Funding to Drive Economic Diversification

CHEYENNE, Wyo. - Gov. Mark Gordon is pleased to announce that the U.S. Economic Development Administration has awarded the City of Kemmerer \$138,950 in grant funding to support redevelopment and revitalization.

The grant will pay half the cost of developing a detailed economic diversification strategy and hiring an impact manager for a two-year period to implement the plan. It will help Kemmerer and Lincoln County prepare, strengthen, and diversify its economy in anticipation of the likely upcoming retirement of the Naughton #1 and #2 coal-fired power plants.



"Our focus is on the workers and communities that will be impacted by these announced closures," Governor Mark Gordon said. "I'm glad to see that the community is taking a proactive role in charting its future."

Kemmerer partnered with Rocky Mountain Power, the Wyoming Business Council, the South Lincoln Economic Development Corporation, the Lincoln County Economic Development Joint Powers Board and Lincoln County to provide the match for the grant.

"It's crucial to have close partnerships with private industry, the county and the state as we move Kemmerer toward some really successful ventures," said Mayor Anthony Tomassi. "We have a really good team."

The diversification study will explore target industries, tourism opportunities and quality of life initiatives to identify specific tasks and achievable goals for Kemmerer to pursue. After the study is complete, Kemmerer will hire an impact manager to carry out the plan.

"The lack of such a position in the past has been one of the biggest reasons our past efforts did not make the progress toward economic diversification we had hoped for," Tomassi said.

Kemmerer's diversification strategy will focus on value-added markets and development for natural resources, manufacturing processes for value-added projects, training and apprenticeships, tourism and entrepreneurial development, and infrastructure improvement.
