# BUILDING DIVISION 

 2022 ANNUAL REPORT

Construction in 2022 was consistent although the total value of construction was less than in 2021. Commercial construction value was significantly lower, new residential values were higher, even though the number of new residential homes was 1 less, and electrical, plumbing and mechanical permits were lower in 2022 than in 2021. There were 28 Certificates of Occupancy issued in 2022, the major projects are listed below. Some of the notable projects completed in 2022 are the Casper College Visual Arts Building, YMCA Pool, the "M" Building, (Two) Dollar General Stores and the (Two) Rescue Mission Housing projects.

## PERMIT REVENUE:

The Community Development Department issued 1,036 Building, 891 Electrical, 1,072 Plumbing and 708 Mechanical permits in 2022.
